## **AMENDMENT**

## 1. PARTIES

This Amendment to the above-referenced Original Contract (hereinafter called "Price Agreement") is entered into by and between EP Blazer LLC dba John Elway Chevrolet (hereinafter called "Contractor"), and the State of Colorado, acting by and through the Department of Personnel & Administration, State Purchasing Office, (hereinafter called the "State" or "SPO").

# 2. EFFECTIVE DATE AND ENFORCEABILITY

This Amendment shall not be effective or enforceable until it is approved and signed by the Colorado State Controller or designee (hereinafter called the "Effective Date"). The State shall not be liable to pay or reimburse Contractor for any performance hereunder including, but not limited to, costs or expenses incurred, or be bound by any provision hereof prior to the Effective Date.

## 3. FACTUAL RECITALS

A. The Parties entered into a Price Agreement effective October 19, 2015 that authorizes providing 2016 or newer fleet vehicles in the State of Colorado's Price Agreement, number 201600000000000137.

#### 4. CONSIDERATION

The Parties acknowledge that the mutual promises and covenants contained herein and other good and valuable consideration are sufficient and adequate to support this Amendment.

#### 5. LIMITS OF EFFECT

This Amendment is incorporated by reference into the Price Agreement, and the Price Agreement and all prior Amendments thereto, if any, remain in full force and effect except as specifically modified herein.

# 6. MODIFICATIONS

The Price Agreement and all prior amendments thereto, if any, are modified as follows:

- A. Commencing on the effective date the Exhibit A(2) price list shall be in affect. All references to Exhibit A and Exhibit A(1) shall also reference Exhibit A(2).
- B. In accordance with the Price Agreement, Section 5.C.i, the State hereby exercises its option for an additional term beginning 10/01/2016 and ending on 09/30/2017 at the same rates and same terms specified in the original Price Agreement and this Amendment, 201600000000000137.

## 7. ORDER OF PRECEDENCE

Except for the Special Provisions, in the event of any conflict, inconsistency, variance, or contradiction between the provisions of this Amendment and any of the provisions of the Price Agreement, the provisions of this Amendment shall in all respects supersede, govern, and control. The most recent version of the Special Provisions incorporated into the Price Agreement or any amendments.

## 8. AVAILABLE FUNDS

Financial obligations of the State payable after the current fiscal year are contingent upon funds for that purpose being appropriated, budgeted, or otherwise made available.
