1. PARTIES

A. The Parties entered into a Price Agreement effective October 19, 2015 that authorizes providing 2016 or newer fleet vehicles in the State of Colorado's Price Agreement, number 201600000000000137.

4. CONSIDERATION

The Parties acknowledge that the mutual promises and covenants contained herein and other good and valuable consideration are sufficient and adequate to support this Amendment.

5. LIMITS OF EFFECT

This Amendment is incorporated by reference into the Price Agreement, and the Price Agreement and all prior Amendments thereto, if any, remain in full force and effect except as specifically modified herein.

6. MODIFICATIONS

The Price Agreement and all prior amendments thereto, if any, are modified as follows:

A. Commencing on the effective date the Exhibit A(1) price list shall be in affect. All references to Exhibit A shall also reference Exhibit A(1).

7. ORDER OF PRECEDENCE

Except for the Special Provisions, in the event of any conflict, inconsistency, variance, or contradiction between the provisions of this Amendment and any of the provisions of the Price Agreement, the provisions of this Amendment shall in all respects supersede, govern, and control. The most recent version of the Special Provisions incorporated into the Price Agreement or any amendment shall always control other provisions in the Price Agreement or any amendments.

8. AVAILABLE FUNDS

Financial obligations of the State payable after the current fiscal year are contingent upon funds for that purpose being appropriated, budgeted, or otherwise made available.
