*Additional court access fees or state DMV fees may apply. There are many DMV and court record repositories that do not have added fees to access, therefore we would not need to charge additionally to the pricing stated. However, for example to access NY's statewide repository, there is a \$95 access fee with which the pricing cannot cover. This type of fee, that is not under ADB control, will be passed through to the client. For verification of Employment, if a third party fee is required to access the information, the client will have an option to have these fees passed through or close the verification. For Education verification, if the Student Clearinghouse or other third party is required to obtain education information, the client will have the option to close the request or pass the third party pass through fees.

Custom Report Creation

While our system provides many canned reports and extracts, should the client require a custom report be created, there will be a \$150/hr fee charged for the work involved in the creation of such custom report.
